2016 PenSoft Payroll

We are preparing 2016 PenSoft Payroll for release on December 14th. Since this is completely new software for most of our customers please install and work with it early because menus have changed and there are many new features.

PenSoft Payroll Hosted Solution

We are excited to announce the addition of PenSoft Payroll Hosted Solution for 2016. Rather than installing the software on your computer, it is installed in the cloud where you have access to it.

The benefits of the PenSoft Payroll Hosted Solution:

- 1. You can access your company payroll from any computer with internet access so you are not restricted to just one location.
- 2. You will not be required to maintain the hardware infrastructure as you are with the desktop application.
- 3. PenSoft Payroll Hosted Solution is billed on a monthly basis versus buying the software on an annual basis.
- 4. Updates will be managed so your software will always be up to date with the latest tax code.
- **Database Corruption**

Database corruption is the unseen gremlin hiding in the shadows when you are busy working in PenSoft Payroll. It's one of the most common causes of data loss for PenSoft customers and it's getting more prevalent. This technical tip is to help you identify behavior that contributes to corrupting the database and processes you can put in place to prevent your database from becoming corrupted.

Known causes of PenSoft Payroll database corruptions:

- Rebooting or turning off the computer when PenSoft Payroll is open
- Keeping PenSoft Payroll open constantly
- Sharing data through backup and restoring on a frequent basis
- Network and media disk errors
- Virus on the system

Preventive measures for protecting your database:

• Proper shut down of the application and the computer is vital to prevent corrupting your PenSoft Payroll database. Shut down PenSoft Payroll by clicking on the file menu and exit or by clicking the "X" button on the top right-hand side of the program window. Never turn off a computer by

unplugging or turning off the power supply. Take the time to properly shut down all applications and the computer. While you cannot control a power outage, you can install UPSs (uninterruptible power supply) to your computer systems and servers.

- Do not leave PenSoft Payroll up and running constantly in the background when not in use. This is especially important in cases of multi-user access in PenSoft Payroll. Having PenSoft Payroll open when the operating system (OS) freezes and the only remedy is a hard boot is sure to result in a corrupted database.
- Sharing data between departments or locations via backup and restore ultimately can result in the corruption of the PenSoft Payroll database. The restore process in the application overwrites the current database. Backing up to and restoring from faulty media can result in an irreparable corruption of the database. The correct method for sharing data is to setup the common data folder on a server and provide access to authorized employees.
- Network and media faults: Wi-Fi connections are convenient and work fine, but multiple users or neighborhood networks have been reported to have abrupt cut offs of the connection.

Q. Is there an automated process to notify the Chief Financial Officer when payroll tax payments are delinquent? The Internal Revenue Service (IRS) sent notices of delinquency, but the notices were only addressed to the payroll manager and were hidden in the desk.

A. The IRS Electronic Federal Tax Payment System is an independent application from PenSoft Payroll and acknowledgements are stored in the EFTPS payment system.

PenSoft recommends implementing internal checks and balances that include segregating duties such as having a second member of the payroll department verify the processing of EFTPS payments and reconciling payroll reports to the verified tax payments. The IRS and other revenue agencies offer the option to send notices to multiple individuals within the company reducing the potential for nondisclosure.

Q. I attended a year-end course and the instructor recommended we verify the wage bases and limits of deductions in our software before processing the first payroll in 2016. How can I update and verify the 2016 retirement plan limits in PenSoft Payroll?

A. PenSoft maintains the wage base limits in PenSoft Payroll so clients do not have to be concerned with updating the limits of pre-defined retirement plans. The retirement plan limits were released October of 2015 and will be included in the initial release of 2016 PenSoft Payroll.

Pre-defined retirement plan deductions display in the view only mode. The following steps provide access to viewing the cut-off limit of a pre-defined retirement plan deduction:

- Click Setup
- Click Company
- Click Deduction List
- Select the retirement plan deduction to verify
- Click Modify

- Secure: Customer runs on a separate instance, so the credentials and URL to access one customer's instance is different from that of other customers. There are detailed procedures in place to ensure the necessary levels of physical security, network security, application security, internal systems security, operating system security and third-party certifications.
- Scalable: Available in three service levels: Basic, Advanced, and Elite. Scales up or down based on demand.
- Infrastructure: Reduced Informational Technology (IT) infrastructure and expense. The IT infrastructure is managed by the host resulting in lower IT costs for hardware, software, and the workforce needed to manage it. Microsoft XP users can continue with PenSoft Payroll without upgrading their operating system with a subscription to PenSoft Payroll Hosted Solution.
- **Disaster Recovery:** Built-in disaster recovery protection. The data center meets or exceeds Tier-3 standards, which ensure that both the infrastructure and application layers are protected from events such as power failures and network outages through redundant Internet connectivity and power supply, including UPS and generators.

This interruption can corrupt the database file if you are writing to it at the time. Another important point is device medias do not have an eternal lifespan and begin to falter after years of extensive use. As mentioned previously, backup/restore from a faulty media can corrupt the PenSoft Payroll database. Be proactive in ensuring your media is in good working order by running scandisk and defrag on a regular basis.

• Virus: Many viruses can infect and damage PenSoft Payroll databases. Unfortunately these viruses can go undetected for long periods of time, even years, and strike when you least expect it. PenSoft strongly recommends installing and regularly updating quality anti-virus software for your systems.

It may be possible to recover from a database corruption but there is no guarantee. PenSoft's software engineers have assisted many customers in this process but are finding it more difficult especially for repeat offenders. PenSoft's policy is to assist customers to the fullest extent possible but it is a team effort requiring cooperation from our customers. When customers do not take the steps necessary to properly handle the database, it becomes a losing battle and results in frustration for both the customer and PenSoft. In instances where the database is beyond repair, the only option for recovery is to restore from a clean backup file or to start over.

Your data is always at risk. Having proper processes in place for using PenSoft Payroll and incorporating adequate and viable backups are important safeguards, but this isn't enough. There's much you can do to prevent a database corruption from occurring but it requires awareness of user and system weaknesses and changing risky behaviors within your processes.

Accordingly, the closing comment is, Backup!! Backup!!!
