Phishing E-Mail Scam

E-mail phishing scams

are evolving at a fast

yber security professionals are warning consumers and business owners of evolving phishing e-mail scams pretending to be from your software providers in an attempt to deceive users into clicking on a false link to install software updates. Upon completion, users think they have downloaded a software update when in fact they have loaded a program designed to track the user's keystrokes, which is a common tactic used by cyber thieves to steal login information, passwords and other sensitive data.

E-mail Scams Be aware of a new phishing e-mail scam directed at software providers. PenSoft knows of no instances to date of phishing e-mails being sent to customers, but customers are encouraged to be on the lookout for these scams and never to

attempt to get users into providing sensitive account information such as passwords, user account numbers, and even to make unnecessary payments.

Once recipients click on the embedded link, they are directed to a website prompting them to download a file appearing to be an update of their software package. The file has a naming convention that uses the actual name of their software followed by an ".exe extension." click on unexpected links in e-mails. Q&A

Q. I need a different address on my Form 941 than all my other tax forms. How can I change the address?

A. The company's address is printed from the company setup and it flows to all forms. There is not an option to override the address on the Form 941.

Q. I am trying to print reports but the print button is cut off at the bottom.

A. It sounds like the screen resolution is set too low. Adjust the screen resolution and you should be able to see the print button.

Q. I entered an incorrect paydate. Can I correct this without having to delete and reenter my payroll?

A. Yes! To change the paydate:

- Click Utilities.
- Click Manage Data.
- Click Change Paydate.
- Highlight the incorrect paydate in the "Select a Paydate" column and then select the correct paydate from the calendar.
- Click OK.

Q. I ordered tax forms in June. When should I receive them?

A. All preordered tax forms shipped on or before November 14th. If you have not yet received your forms call 757-873-2976 and the Sales Department will track your package. Once you receive your package please open it immediately to ensure you received all the forms ordered.

to go the website for the update. The update notice contains a link to PenSoft Registered Users Resource Site: **www.pensoft.com/ customers/softwareupdates.aspx**

To help customers avoid becoming a victim of this type of phishing scam, here are a few ways you can ensure you are downloading/ installing an authentic update from PenSoft:

- Check for updates from within PenSoft Payroll. Under Utilities, click Check for Update. The system notifies users if they need to update. If you need to update, click the Update button and you will automatically begin the process of installing the update. The installation application clearly states what you are installing.
- Go to the PenSoft website directly from your browser versus clicking on a link. From the home page go to Customers and select Software Updates. Access to the PenSoft update through the website requires registered users to log in using their unique customer number and password.
- PenSoft's naming convention for updates are different for each update and the files never contain the company name "PenSoft."
- Technology provides convenience through the option to download updates, but PenSoft registered users can subscribe to receive updates via CD. There is a cost for selecting updates via CD. Contact Sales and Administration for pricing at 888-736-7638.

PenSoft users are no strangers to cyber criminals' attempts to obtain access to sensitive information through targeted phishing attacks and it is our goal to help ensure you do not become a victim.

The best protection against phishing attacks is a combination of awareness and training to limit the success of the attacks and the implementation of strong technical controls designed to identify/prevent your systems from being compromised.

Downloading PenSoft Payroll to Multiple Machines on a Network?

Do you have multiple machines using PenSoft Payroll? Would you like to save time by updating all your machines with one download?

Save time with one download! Downloading once to update all your machines also keeps all instances of PenSoft Payroll running on the same version! No longer worry about version conflicts within your office!

Visit **www.pensoft.com/customers/softwareupdates.aspx** and download the update to a location ALL your computers have access to. Then update each computer from that one download. To make sure all your computers are running the same version disable the system option to check for program updates at startup.

Highlights of Key Changes Impacting Payroll Year-End

- Social Security (OASDI) Wage Base for 2017 is \$127,200
 - Overtime Rule Implementation December 1st
 - Payroll's role in ensuring compliance
 - Impacts salary requirement test only, no changes to duties' tests
- W-2 Form due date for filing with Social Security Administration accelerated to January 31, 2017
 - Objective is to help combat refund fraud
 - Form 1099-MISC due date for filing with IRS also moved up (Box 7 amounts only) to January 31, 2017

- Affordable Care Act Reporting for 2016!
 - NO extended due dates for Forms 1094/1095
 - Stricter criteria for determining penalties due to incorrect reports
- Failure to file accurately and timely—penalties increased
- Paid Leave-Federal, state and local ordinances

Things to Watch For in 2017

- Increased DOL enforcement and compliance efforts regarding misclassifications of worker status
- Increased security protocols for State and fed tax agencies multi-factor authentication
