The Internal Revenue Service (IRS) recommends employers and payroll service providers encourage employees to verify their 2018 withholding by using the IRS calculator.

Q&A

Q. Payroll needs to record imputed income for an employee's unsubstantiated medical health claims. It is reportable on their W-2, taxable for Federal, State, and Social Security/Medicare Taxable wages. How do I setup a custom payment without creating a monetary net check amount?

A. PenSoft Payroll supports the ability to setup non-monetary incomes. To create the user-defined income in the company list:

- Click Company on the toolbar
- · Highlight the desired company
- Click Setup
- Click Payroll Incomes
- Click Add
- Enter the title and abbreviation
- Remove checkmark for "To count towards minimum wage"
- Check "Non-monetary income"
- We recommend checking "Include in Form W-2, Box 14" box
- In the calculation drop down menu select Variable Amount
- Enter 0.00 in the rate box
- Click OK
- Click Close
- Add income to applicable employees

Q. How do I include the client's SSN as the Tax ID on the Form 1099-MISC?

A. To add the recipient's SSN as the Tax ID on the Form 1099-MISC:

- Click Personnel on toolbar
- Click Form 1099-MISC
- Highlight the desired recipient
- Click Setup
- Click Identification
- Place the cursor in the Social Security Number field
- Enter the recipient's Social Security Number
- Click OK
- Click Close

Q. How do I setup housing allowance to exclude the allowance from the chaplain's gross income and add in Box 14 of the W-2?

A. To create a user-defined income for housing allowance:

- Click Company
- Highlight the desired company
- Click Setup
- Click Payroll Incomes
- · Click Add
- Enter in the title and abbreviation Housing Allowance
- Remove checkmark for "To count towards minimum wage"
- Check "Include in Form W-2, Box 14" box
- In the calculation drop down menu select Variable Amount
- Enter 0.00 in the rate box
- Uncheck the tax items the income is NOT subject to
- Click OK
- Click Close
- Add income to applicable employees

Q. How do we process benefit payments of our IRS qualified defined contribution plan? The benefit payments are non-periodic, subject to a mandatory 20% withholding for Federal taxes and mandatory state tax withholding but not subject to social security or Medicare taxes.

A. PenSoft Payroll supports the ability to create the user-defined income and setup the tax configuration to withhold 20% federal, mandatory state income tax withholding (SITW), and not have the payment subject to social security or Medicare taxes.

The complexity of setting up the income per your specifications makes it complicated to explain in a newsletter. When creating user-defined incomes/payments with "special" tax configuration, call Program Support for a Program Consultant to walk you through the process, step by step.

Prior to contacting Program Support, speak with your tax consultant to obtain the details of the tax implications for the federal and state taxes including unemployment taxes.

Blockchain

You may have heard about a technology called "blockchain", and may wonder what impact it will have on you and how you do payroll. While there are a number of articles on the Internet that go into more depth, let's take a quick look at what blockchain is, how it works, and what it can do for us.

First, blockchain is a concept that allows the creation of what amounts to a distributed ledger - just like the ledger you might keep for your organization, except that everyone participating in the blockchain has an identical copy of the ledger. Since everyone has a copy, no one can cheat, or modify the contents.

Blockchains record the result of transactions, whether it's money moving from one person to another, or an employee punching in to work at a particular time. Any time a transaction takes place a new "block" is added to the "chain", a "hash" or signature of all the previous blocks is added to the new block so they can't be modified, and the new blockchain is distributed to all the participants. Everyone has the same, unalterable information all the time.

You may have heard of Bitcoin, or other "cryptocurrencies" that actually assign monetary value for work done to maintain a blockchain. While it's uncertain if or when employees would ever be paid in cryptocurrency, the possibility exists. More foreseeable scenarios include using blockchain to track payments between businesses, and between businesses and government agencies; tracking employee HR information; employee work history. The nature of blockchain is that no one entity owns the chain, so there's no middleman that has to coordinate transactions, or with whom a transaction could go awry.
